MODE OF MEETING

The Seventeenth ("17th") Annual General Meeting ("AGM") of the Company will be held as a virtual meeting via live streaming and online remote voting from the Broadcast Venue above. This is in line with the revised Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 7 April 2022 (including any amendments that may be made from time to time) ("Guidance Note").

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Guidance Note which require the Chairman of the meeting to be present at the main venue of the meeting. Members and/or proxy(ies) and/or corporate representative(s) and/or attorney(s) **WILL NOT BE ALLOWED** to be physically present at the Broadcast Venue on the day of the 17th AGM. Members are instead invited and encouraged to participate in the upcoming virtual 17th AGM from the comfort of your home or office.

REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Members/proxies/corporate representatives/attorneys are to attend, speak (including posing questions to the Board of Directors of the Company (the "Board") via real time submission of typed texts) and vote (collectively, "participate") remotely at the 17th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Share Registrar" or "TIIH") via its TIIH Online website at https://tiih.online.

Members who appoint proxies to participate via RPV in the 17th AGM must ensure that the duly executed form of proxy are deposited in a hard copy form at the Registered Office of the Company at RedQ, Jalan Pekeliling 5, Lapangan Terbang Antarabangsa Kuala Lumpur, 64000 KLIA, Selangor Darul Ehsan, Malaysia ("Registered Office") or by electronic lodgement via TIIH Online website at https://tiih.online not later than 2.00 p.m. on Tuesday, 4 June 2024. Faxed copies of the duly executed form of proxy are not acceptable.

Authorised representatives of corporate members must deposit their original or duly certified certificate of appointment of authorised representative at the Registered Office not later than **2.00 p.m. on Tuesday**, **4 June 2024** to participate via RPV in the 17th AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney at the Registered Office not later than **2.00 p.m. on Tuesday, 4 June 2024** to participate via RPV in the 17th AGM.

A member who has appointed a proxy or authorised representative or attorney to participate in the 17th AGM via RPV must request his/her proxy or authorised representative or attorney to register himself/herself for RPV at the TIIH Online website at https://tiih.online.

As the 17th AGM of AirAsia X is a virtual meeting, members who are unable to participate in this 17th AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

PROCEDURES FOR REMOTE PARTICIPATION AND VOTING VIA RPV

Members/proxies/corporate representatives/attorneys who wish to participate in the 17th AGM remotely using the RPV are to follow the requirements and procedures as summarised below:

(a)	Register as a user with TIIH Online	 Using your computer, access the website at https://tiih.online. Register as a user under the "e-Services" select "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance. Registration as a user will be approved within one (1) working day and you will be notified via e-mail. If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.
(b)	Submit your request to attend 17th AGM remotely	 Registration is open from 2.00 p.m. Tuesday, 30 April 2024 until the day of 17th AGM on Thursday, 4 June 2024. Member(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 17th AGM to ascertain their eligibility to participate the 17th AGM using the RPV. Login with your user ID and password and select the corporate event: "(REGISTRATION) AAX 17TH AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at 28 May 2024, the system will send you an e-mail after 4 June 2024 to approve or reject your registration for remote participation. (Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).

(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) AAX 17TH AGM" to engage in the proceedings of the 17th AGM remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavour to respond to questions submitted by remote participants during the 17th AGM. If there is time constraint, the responses will be e-mailed to you earliest possible, after the meeting.

(e)	Online Remote Voting	•	Voting session commences from 2.00 p.m. on Thursday, 6 June 2024 until a time when the Chairman announces the completion of the voting session of the 17th AGM. Select the corporate event: "(REMOTE VOTING) AAX 17TH AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	•	Upon the announcement by the Chairman on the closure of the 17th AGM, the live streaming will end.

Note to users of the RPV:

- 1. Should your application to join the 17th AGM be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the 17th AGM will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
